Child Development Services: The One Hope United Child Development Program supports families by providing accessible, affordable, high-quality child care and early education services that encourage the social, emotional, intellectual and physical development of children. In FY16, we served more than 2,149 children through child development services, and all of them surpassed outcome goals for social/emotional, cognitive development, language and physical development.

4b (Code:) (Expenses \$ 8,403,292. including grants of \$ 1,703,923.) (Revenue \$) Foster Care/Placement: One Hope United offers placement services when risk to a child from abuse and neglect is so great and the family situation is so deteriorated that the child must be removed from his or her home. We served 614 children through placement services in FY16, with about 86 percent of these children receiving foster care services. In foster care, we provide case management services with the child while working to strengthen the biological family so that the child may safely return home.

4c (Code:) (Expenses \$ 4,165,477. including grants of \$ 13,230.) (Revenue \$ 398,894.) Community Based Family Support Services: One Hope United provides on-site and outreach counseling to families in their homes. Services are aimed at preserving families, strengthening family functioning and preventing family breakdown. In FY16, we served 2,315 clients and families through community based family support services.
